Buyer will pay the sum of \$\_\_\_\_\_ as the full purchase price of the puppy. Buyer will pay to breeder a non refundable deposit of \$\_\_\_\_\_ at the time of execution of this agreement and will pay the balance at the time of puppy pick up/delivery.

The puppy is sold to buyer and buyer purchases and accepts the puppy in "as is" condition and breeder makes no guarantee of warranties, express or implied concerning the puppy's health except as expressly and specifically set forth as follows:

- Buyer must have puppy examined by a Licensed Veterinarian within 72 hours after buyer has picked up puppy from breeder. If buyers veterinarian determines the puppy to have a serious illness or congenital defect, Buyer may return the puppy to Breeder for another puppy, not a refund, provided the puppy is in the same condition as at the time of delivery and provided buyer delivers a verified letter to breeder from the veterinarian confirming the puppy has a serious illness or congenital defect which existed in the puppy at the time it was removed from the breeders premises. This is subject to confirmation by breeders choice of veterinarians.
- Breeder guarantees that for a period of (2) two years from the date of birth of the puppy, the puppy will not have or develop hereditary cataracts, hip dysplasia, heart defects, PRA, or Von willebrands. This guarantee is non transferable. If the buyer's veterinarian determines the puppy to have any of said conditions the buyer must have the condition confirmed by a licensed specialist at eighteen months of age, no claim will be considered prior to eighteen months of

age. Breeder will provide a new puppy for buyer, provided buyer delivers to breeder a verified letter from buyer's veterinarian confirming that the puppy has one of the above listed conditions.

The puppy shall be given adequate housing and shade and shall be properly and sufficiently fed. The puppy shall not be neglected or mistreated in any way. Reasonable precautions shall be taken to prevent the acquiring of hereditary defects: None of the following until puppy is (2) years of age: tread milling, jogging, standing on back legs, excessive ball play or running.

Buyer must have the puppy fixed at an age of (6) six months. Proof of spay/neuter shall be provided to breeder. If puppy is not spayed/neutered by the age of (7) months then buyer may be asked to relinquish the dog to the breeder.

Breeder warrants that she is the lawful owner of the puppy, that the puppy is free from all encumbrances and that she has the right to sell the puppy. Breeder will defend the title to the puppy from all lawful claims and demands.

In the unlikely event that litigation is necessary; both parties agree that it shall be held in Monroe county, New York.

Buyer has read and understands all the terms and provisions contained in the contract. Buyer understands the terms and provisions contained constitute a binding agreement of the parties with respect to the sale of said puppy. Buyer is hereby stating that s/he will get the puppy fixed when the puppy is (6) months of age.
